Crook & Chase's Willie Nelson Flyaway to The Greek Theatre Sweepstakes
OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION PERIOD:** Crook & Chase's Willie Nelson Flyaway to The Greek Theatre Sweepstakes (the "Sweepstakes") begins at 12:00:01pm Central Time ("CT") on August 13, 2010 and ends at 11:59:59am CT on August 30, 2010 (the "Promotion Period"). All entries must be received during the Promotion Period. The Sponsor's computer is the official time keeping device for this Sweepstakes.
2. **ELIGIBILITY:** Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States and District of Columbia who are at least eighteen (18) years of age or older as of the date of entry. Subject to all applicable federal, state, and local laws and regulations. Void in Alaska, Hawaii, and where prohibited or restricted by law. Individuals who have won a prize from the Radio Show within one hundred eighty (180) days prior to the start date of this Sweepstakes are not eligible.

Employees of Premiere Radio Networks, Inc. (the "Sponsor"), Crook & Chase Countdown (the "Radio Show"), Nederlander Concerts, Inc. (the "Prize Provider") (collectively, the "Sweepstakes Entities"), each radio station contracted to broadcast the Radio Show, and their respective subsidiaries and affiliated companies, divisions, parent companies, officers, directors, agents and advertising agencies, as well as members of the immediate family of any such employees, are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

3. **HOW TO ENTER:** Submit your entry by visiting <http://www.crookandchase.com> during the Promotion Period and follow the Sweepstakes link to review the submission guidelines and complete all required information in the online entry form.

Entries limited to one (1) entry per participant. Multiple participants are not allowed to use the same email address. Any attempt by a participant to acquire more than one (1) entry by using numerous email addresses, registrations, identities, or any other methods will void that participant's entries and that participant may be disqualified. The use of automated software or computer programs to register or enter the Sweepstakes is prohibited, and any individual who uses or attempts to use such methods to register or to enter will be disqualified. Valid entries must contain all information requested. Incomplete and/or multiple entries will be disqualified. In the event of a dispute, the authorized account holder of the email address used to enter will be deemed to be the participant. The authorized account holder is the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. Sweepstakes winner(s) will be selected from online entries only. One (1) prize per household. The Sponsor will not verify receipt of entries. By entering, participants acknowledge compliance with the Official Rules, including eligibility requirements. Responsibility for receipt of entry rests solely with the participant.

4. **PRIZE DRAWING:** A random drawing will be conducted by the Sponsor on or about August 30, 2010 from among all eligible entries received during the Promotion Period. Odds of winning depend upon the number of eligible entries received. Winner(s) agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions are final on all matters relating to this Sweepstakes.
5. **PRIZE(S): ONE (1) GRAND PRIZE;** A trip for two (2) people to see Willie Nelson perform live in Los Angeles, California at the Greek Theatre. The trip includes round trip coach airfare for two (2) people on American Airlines, or its Airline Associates (American Eagle® or the AmericanConnection® carriers) (the "Air Transportation") between the major US gateway airport served by American Airlines or it's Airline Associates nearest the winner's residence (as determined by American Airlines) and Los Angeles, CA, two (2) nights hotel accommodations (double occupancy), two (2) tickets to see Willie Nelson perform at the Greek Theatre (the "Concert") on September 24, 2010, and two (2) VIP Room passes (Approximate Retail Value ("ARV"): \$2,500.00). Travel will take place between

September 23-25, 2010 and is based on travel restrictions and blackout dates. If the winner is unavailable for travel on the designated dates, the winner will be disqualified and the Sponsor reserves the right to select another winner in its sole discretion and if time permits. Airline tickets valid on American Airlines-operated, published, scheduled service only from the airport nearest the winner's residence served by American Airlines. If the winner does not live in a city served by American Airlines, he/she is responsible for transportation to the nearest airport served by American Airlines. Winner and guest must travel out of the same airport and on the same itinerary. Minor must be accompanied by a parent or legal guardian. Winner and guest are responsible for all necessary travel authorizations such as passports, visas, and/or government identification and for any travel insurance. Meals and beverages, incidentals, gratuities, phone calls, luggage fees, and any and all other expenses not specifically mentioned herein are the sole responsibility of the winner. Prize Provider, in its sole discretion, reserves the right to provide ground transportation in lieu of air transportation if the winner resides within one hundred (100) miles from the trip destination. If, for any reason, the Concert is postponed or canceled, the Sweepstakes Entities are not responsible, and the trip will be awarded without the Concert on the same itinerary. The Prize Provider reserves the right to substitute any portion of these prizes, including travel dates and destination, for a prize of equal or greater value. No transfer, assignment, change of the prize, or cash substitution is permitted except at the sole discretion of the Sponsor. If a winner cannot be contacted or is disqualified, the Sponsor reserves the right to determine an alternate winner in its sole discretion. Unclaimed prize(s) will not be awarded. 6. **RELEASE FORM:** Winner will be notified by telephone, mail, and/or email on or about August 30, 2010 and will be given five (5) days to confirm receipt of notification. Sponsor is not responsible for any change of email address, mailing address, and/or telephone number of participants. If the winner cannot be contacted from the information provided on the online entry form, the Sponsor reserves the right to select another winner at its sole discretion. Winner (or his/her parent or legal guardian if a winner is deemed a minor in his/her state of residence) will be required to complete and return an Affidavit of Eligibility/Liability Release (including, where permitted, a Publicity Release) (the "Affidavit") within twelve (12) days of notification. Failure to return the executed Affidavit within that time may result in forfeiture of prize and random selection of alternate winner from remaining eligible entries. A parent or legal guardian of any participant who is a minor must sign a release on behalf of the minor for the minor to be eligible to receive a prize. A prize won by a minor may be awarded to the minor's parent or legal guardian in the Sponsor's sole discretion. The Sponsor is not responsible for human, mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: any form of active or passive filtering, insufficient space in participant's e-mail account to receive e-mail messages, failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet, or on any website, or lost or unavailable network connections which may limit an online participant's ability to participate in the Sweepstakes, and any injury or damage to participant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in the Sweepstakes. No mechanically reproduced entries or facsimiles will be accepted. Entries void if incomplete, defective, altered, forged, illegible, or received outside authorized channels.
